STALLION SERVICE CONTRACT

This Contract is made by and between _____, hereinafter referred to as “mare owner,” and K AND B FARMS, hereinafter referred to as “stallion owner.”

PURPOSE

The purpose of this Contract is to create an agreement for the breeding of _____, a mare, Registration No. _____, to the stallion, My Majestic Trinity, Registration No. ApHC #623880, for the _____ breeding season.

FEES

The fees for the services of the stallion shall be a booking fee in the amount of \$_____ which is due and payable at the time of the signing of this Contract. A stallion service fee in the amount of \$_____ is payable at the time the mare is removed from the breeding farm. The booking fee shall be deducted from the stallion service fee.

GUARANTEE

The stallion service fee shall include a live foal guarantee (LFG). If the mare fails to conceive and produce a live foal that is able to nurse, the mare owner is entitled to the return of the booking fee and stallion service fee, less the costs of care for the mare and any related veterinary expenses.

VETERINARY CERTIFICATE

Stallion owner may request a veterinary certificate stating that the mare is fit to breed and free of disease.

DEATH OR INABILITY OF STALLION OR MARE TO BREED

This Contract shall be null and void and a refund of stallion service fees shall be made to the mare owner if the stallion or mare should die or become unfit for service prior to the servicing of the mare in the present breeding season. Mare owner may substitute another mare with the consent of stallion owner with no additional fees.

ADDITIONAL FEES FOR CARE OF MARE

Before removing the mare from the breeding farm, a daily boarding fee of \$_____ per day must be paid, regardless of the outcome of the breeding, and all veterinary expenses for the mare which have been paid by stallion owner shall be reimbursed.

BREEDER'S CERTIFICATE

A breeder's certificate will be issued to mare owner upon the birth of a live foal. The breeder's certificate will be provided upon written notification to stallion owner of the birth of the foal.

PEDIGREE INFORMATION

Mare owner shall provide to stallion owner the written information on the pedigree and necessary breeding information at the time of this Contract.

NONASSIGNMENT

This Contract may not be assigned or transferred by mare owner without the prior written permission of stallion owner.

LAWS GOVERNING

This Contract shall be governed by the laws of the Commonwealth of Pennsylvania.
